Which included estimated assessments to benefitted property owners and estimated the separable maintenance costs so as to better describe the estimated assessments to affected landowners; and

- 4. The estimated benefits are greater than the total estimated cost, including damages.
- 5. The proposed drainage project will be of public utility and benefit, and will promote the public health.
- 6. The proposed drainage project is practicable.
- 7. Separable maintenance recommended by the engineer is approved.

NOW THEREFORE, The Blue Earth County Board of Commissioners, as Drainage Authority for Blue Earth County Ditch 28, hereby adopts and confirms the Viewers' Report as amended and establishes the proposed Improvement to Blue Earth County Ditch 28 as reported and set forth in the Final Engineer's Report and Viewers' Report.

RESOLUTION RELATING TO FINANCING OF CERTAIN PROPOSED PROJECTS TO BE UNDERTAKEN BY THE COUNTY; ESTABLISHING COMPLIANCE WITH REIMBURSEMENT BOND REGULATIONS UNDER THE INTERNAL REVENUE CODE

BE IT RESOLVED, by the Board of County Commissioners (the 'Board') of Blue Earth County, Minnesota (the 'County') as follows:

- 1. Recitals.
- (a) The Internal Revenue Service has issued Section 1.150-2 of the Income Tax Regulations (the "Regulations") dealing with the issuance of bonds, all or a portion of

the proceeds of which are to be used to reimburse the County for project expenditures made by the County prior to the date of issuance.

- (b) The Regulations generally require that the County make a declaration of its official intent to reimburse itself for such prior expenditures out of the proceeds of a subsequently issued series of bonds within 60 days after payment of the expenditures, that the bonds be issued and the reimbursement allocation be made from the proceeds of such bonds within the reimbursement period (as defined in the Regulations), and that the expenditures reimbursed be capital expenditures or costs of issuance of the bonds.
- (c) The County desires to comply with requirements of the Regulations with respect to certain projects hereinafter identified.

2. Official Intent Declaration.

(a) The County proposes to undertake the following project or projects and to make original expenditures with respect thereto prior to the issuance of reimbursement bonds, and reasonably expects to issue reimbursement bonds for such project or projects in the maximum principal amounts shown below:

Project: County Ditch 28 Maximum Amount of Bonds Expected to be Issued for Project: \$3,000,000.00

(b) Other than (i) de minimis amounts permitted to be reimbursed pursuant to Section 1.150-2(f)(1) of the Regulations or (ii) expenditures constitution preliminary expenditures as defined in Section 1.150-2(f)(2) of the Regulations, the County will not seek reimbursement for any original expenditures with respect to the foregoing projects paid more than 60 days prior to the date of adoption of this resolution. All original expenditures for which reimbursement is sought will be capital expenditures or costs of issuance of the reimbursement bonds.

3. Budgetary Matters.

As of the date hereof, there are no County funds reserved, pledged, allocated on a long term basis or otherwise set aside (or reasonably expected to be reserved, pledged, allocated on a long term basis or otherwise set aside) to provide permanent financing for the original expenditures related to the projects, other than pursuant to the issuance of the reimbursement bonds. Consequently, it is not expected that the issuance of the reimbursement bonds will result in the creation of any replacement proceeds.

4. Reimbursement Allocations.

The County's financial officer shall be responsible for making the "reimbursement allocations" described in the Regulations, being generally the transfer of the appropriate amount of proceeds of the reimbursement bonds to reimburse the source of temporary financing used by the County to make payment of the original

expenditures relating to the projects. Each reimbursement allocation shall be made within 30 days of the date of issuance of the reimbursement bonds, shall be evidenced by an entry on the official books and records of the county maintained for the reimbursement bonds and shall specifically identify the original expenditures being reimbursed.

FINDINGS AND ORDER ON PETITION FOR REMOVAL OF PROPERTY FROM DRAINAGE SYSTEMS

This matter came before the Blue Earth County Board of Commissioners, acting as the drainage authority for Blue Earth County Ditch No. 28 and Judicial Ditch No. 15, Blue Earth County, Minnesota on November 18, 2014, for a hearing and proceedings on the Petition for Removal of Property from Drainage Systems filed by John McMonagle ("Petitioner"). The hearing was continued to March 17, 2015 and further continued to September 8, 2015. Based upon those proceedings, the Drainage Authority hereby makes the following:

FINDINGS

- 1. Blue Earth County Ditch No. 28 ("CD 28") is a public drainage system in Blue Earth County, Minnesota.
- 2. Judicial Ditch No. 15 ("**JD 15**") is a public drainage system in Blue Earth County, Minnesota.
- 3. The Blue Earth County Board of Commissioners is the drainage authority for CD 28 and JD 15.
- 4. The Petitioner owns property which previously has been assessed for benefits for CD 28, consisting of the following, all located in Blue Earth County, Minnesota:
 - a. The NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 28-107-29;
 - b. The SW \(^{1}\)4 of the NW \(^{1}\)4 of Section 28-107-29;
 - c. The NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 29-107-29;
 - d. The SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 29-107-29.
- 5. The Petitioner owns property which previously has been assessed for benefits for JD 15, consisting of the following, all located in Blue Earth County, Minnesota:
 - a. The NW \(^{1}\)4 of the SW \(^{1}\)4 of Section 28-107-29;

- b. The SW \(^{1}\)4 of the NW \(^{1}\)4 of Section 28-107-29.
- 6. The waters from Petitioner's property have been diverted from the CD 28 and JD 15 drainage systems, or Petitioner's property cannot significantly or regularly use the CD 28 and JD 15 drainage systems.
- 7. Petitioner's property is not benefited by the CD 28 or JD 15 drainage systems, except an approximately 6-acre building site in the Northeast Quarter of the Northeast Quarter of Section 29-107-29 which is benefited by CD 28.
- 8. Removing the rest of Petitioner's property from the CD 28 and JD 15 drainage systems will not prejudice property owners and property remaining in the CD 28 or JD 15 drainage systems.
- 9. Notice of the hearing on the Petition was provided in the manner required by Minn. Stat. § 103E.805, subd. 3(a).

ORDER

Based on the above findings, it is ordered that Petitioner's property, as described above, is hereby removed from the CD 28 and JD 15 drainage systems, except an approximately 6-acre building site in the Northeast Quarter of the Northeast Quarter of Section 29-107-29, which shall remain in CD 28.
