2. The approved final plat must be recorded within 12 months of receiving final approval from the Planning Commission and Board of Commissioners. Final plat approval shall become null and void 12 months after approval, unless the subdivider applies for and is granted an extension of time by the Planning Commission and Board of Commissioners as set forth in section 20-155, pertaining to extensions of time.

This conditional use permit shall become effective immediately upon its passage and without publication.

THE PROPERTY IS LOCATED IN THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 19, DECORIA TOWNSHIP. (T-107-N, R-26-W)

WHEREAS, Bradley and Kay Schultz acting as agents for Robert A Erlandson and Virginia Erlandson, owners of the following real estate in the County of Blue Earth, Minnesota, to wit:

Part of the Southwest Quarter of the Northeast Quarter of Section 19, Decoria Township as shown on Attachment A- General Location Map.

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 27-15), a copy of said report has been presented to the Planning Commission; and,

WHEREAS; the Planning Commission of the County on the 7th Day of October, 2015, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter to the County Board with a recommendation for approval subject to conditions contained in staff report PC 27-15 and,

WHEREAS; the County Board on the 20th day of October, 2015, held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to approve the request subject to conditions included in staff report PC 27-15 and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

- 1. That the proposed use conforms with the county land use plan.
- 2. The demonstrated need for the proposed use.
- 3. That the proposed use will not degrade the water quality of the county.
- 4. That the proposed use will not adversely increase the quantity of water runoff.
- 5. That soil conditions are adequate to accommodate the proposed use.
- 6. That the proposed use does not create a potential pollution hazard.
- 7. That adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.
- 8. That the conditional use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted.

- 9. That the establishment of the conditional use will not impede the normal and orderly development and improvement of surrounding vacant property for predominant uses in the area
- 10. That site specific conditions and such other conditions are established as required for the protection of the public's health, safety, morals and general welfare.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the request for a Conditional Use Permit for the movement or placement of more than 50 cubic yards of material within the Bluff Impact Zone in the Conservation District in part of the Southwest Quarter of the Northeast Quarter of Section 19, Decoria Township (T-107-N, R-26-W) is hereby **granted** with the following conditions:

- 1. Prior to the commencement of the project, adequate erosion control shall be installed on both sides of the access road crossing. The erosion control must be entrenched and maintained throughout the duration of the project until vegetation can be established.
- 2. If required, an updated wetland delineation showing the areas specific to the project shall be submitted to our office for review, prior to the commencement of the project.
- 3. If found in the surrounding area, no wetlands can be negatively impacted by this project.
- 4. The project shall be built to the specifications provided by Bolton & Menk, Inc. using a 2:1 (Horizontal: Vertical) slope.

2016-2017 County MFIP Biennial Service Agreement/MRCI Employment Services:

A contract to provide employment services under the biennial service agreement that is submitted annually to the State by Human Services. This is a renewal agreement of the Consolidated Grant which has decreased \$32,360.00 since the previous year's grant, totaling \$729,928.00 for the 2016-17 budget cycle. The contract for MRCI, which is part of this overall resource, runs from January 1, 2016, through December 31, 2016.

MRCI/SNAP (Supplement Nutrition Assistance Program):

Renewal of a contract to provide employment services to SNAP recipients. The program funds are an increase from the last federal fiscal year (previously \$22,400.00, current allocation \$41,000.00). The term of the SNAP employment contract is October 1, 2015, through September 30, 2016.

United Way:

A agreement to formally establish a partnership agreement with United Way to continue to be able to administer programs funded through the United Way. No specific fiscal implications are included in the partnership agreement. The term of the agreement is January 1, 2016, through December 31, 2016.

Minnesota Department of Health/Hepatitis B Follow Up and Immunization Practices:

A grant agreement to provide services in the following areas:

- 1. Perinatal Hepatitis B
- 2. Immunization Improvement Practices

The term of the contract is October 1, 2015, through September 30, 2018.

Minnesota Department of Health/SHIP (Statewide Health Improvement Program):

A five-year grant agreement to convene, coordinate, and implement evidence-based strategies targeting a reduction of Minnesotans who are obese, overweight, or are using tobacco. Strategies include policy changes, systemic interventions, and environmental changes.

- The previous 12-month grant was \$176,575.00.
- The current 12-month grant, year one, amount is \$207,817.00, which represents a 17-percent increase from the previous base funding year.
- Year two amount is \$215,958.00, which is a 4-percent increase from year one.
- Year three through five is \$208,958.00, which represents a 3-percent decrease from year two.

The term of this agreement is November 1, 2015, through October 31, 2020.

Advisory Committee Appointment:

Appoint community member, Ardys Korstad, to the Human Service Advisory Committee. Ms. Korstad is a resident of Blue Earth County District #4.
