The County Board of Commissioners met in the Commissioners' Room at 9:00 AM.

Present were Chairperson Katy Wortel, Commissioners Kip Bruender, Colleen Landkamer, Tom McLaughlin and Bob Roberts. Also present were County Administrator Dennis McCoy and County Attorney Ross Arneson.

AMENDED AGENDA

Commissioner Landkamer moved and Commissioner Bruender seconded the motion to approve the amended agenda to include a revised personnel agenda. The motion carried. 2006-100

PLEDGE

All present said the Pledge of Allegiance to the Flag.

COMMITTEE REPORTS

The Commissioners reported on the committees they attended since the last Board Meeting.

PLANNING AND ZONING

Mr. George Leary, Land Use/Natural Resource Planner – Feedlot Specialist presented the following item to the Board.

Commissioner Roberts moved and Commissioner Bruender seconded the motion to approve the following resolution:

RESOLUTION GRANTING A CONDITIONAL USE PERMIT TO CONSTRUCT ONE TOTAL CONFINEMENT SWINE BARN CREATING A NEW FEEDLOT WITH 400 ANIMAL UNITS LOCATED IN THE SOUTHEAST 1/4 OF THE SOUTHEAST QUARTER OF SECTION 18, LYRA TOWNSHIP

WHEREAS, David Hollerich, owner of the following real estate in the County of Blue Earth, Minnesota, to wit:

East Half of Southeast Quarter (E ½ of SE 1/4) and the Southwest Quarter of Southeast Quarter (SW 1/4 of SE 1/4), Section Eighteen (18), Township One Hundred Six (106), Range Twenty-seven (27), containing 120 acres, more or less.

has applied for a Conditional Use Permit to construct one total confinement finishing barn creating a new feedlot of 1,000 grow/finish pigs or 400 animal units. The dimensions of the proposed barn are 102 feet x 112 feet and will be located in the A, agricultural zoned district; and

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC03-06), a copy of said report has been presented to the County Board; and

WHEREAS, the Planning Commission of the County on the 1st day of March, 2006, following proper notice, held a public hearing regarding the request and, following the hearing, adopted a recommendation that the request for a Conditional Use Permit be granted; and

WHEREAS, the Blue Earth County Board of Commissioners finds that:

- 1. That with proper management of the proposed barn and with proper manure application, the Conditional Use should not be injurious to the use and enjoyment of other property in the immediate vicinity designated for agricultural uses.
- 2. That with proper management of the proposed barn and with proper manure application, this facility should not constitute a pollution problem.
- 3. That the predominant use in the area is agriculture. The Conditional Use should not impede the normal and orderly development and improvement of surrounding vacant property for agricultural uses.
- **4.** Adequate utilities, access roads, drainage and other necessary facilities have been or will be provided.

- **5.** Adequate measures will be taken to provide sufficient off-road parking and loading space to serve the proposed use.
- **6.** Soil conditions are adequate to accommodate the proposed request.
- 7. Proper facilities will be provided which will eliminate any traffic congestion or traffic hazard which may result from the proposed use.
- **8.** The feedlot is not greater than the feedlot standards allowed in the A, Agricultural Zoning District.
- **9.** The proposed use is consistent with the County Land Use Plan.
- **10.** That the proposed use does not include residential development.
- 11. That the proposed use does not include industrial development.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the request for a Conditional Use Permit, to create a new feedlot by constructing one total confinement swine barn in an Agriculture Zoning District, is granted with the following conditions:

- 1. That the total confinement barn conforms with the site plan attached to this report PC 03-06.
- 2. That the proposed barn be located on a single, legally described parcel consisting of a minimum of ten contiguous acres. The parcel shall be a parcel of record, properly recorded in the Blue Earth County Land Records Office.
- **3.** That the applicant must obtain a Blue Earth County Feedlot Permit before any animals are placed in the barn.
- 4. That the applicant obtain a Blue Earth County Construction Permit and an MPCA Construction Short Form Permit before building begins and within one year from the date the County Board of Commissioners approves the Conditional Use Permit. The permit shall be rendered invalid if application for a Construction Permit is not made within this one year period. Time extensions for Conditional Use Permits must be obtained from the County Board of Commissioners subsequent to a public hearing conducted by the Planning Commission.

- 5. That the applicant shall prepare and submit to the Environmental Services Office Staff design plans and specifications meeting the requirements of State Feedlot Regulations Chapter 7020.2100 Subpart 4 items A through N prior to obtaining a construction permit. Design plans and specifications must be prepared and signed by a design engineer.
- 6. That application of manure be on the land documented in the aerial photos included in the State of Minnesota Application for Construction and Operation of an animal feedlot. The application of manure shall comply with standards set forth by the MPCA and Blue Earth County.
- 7. That the disposal of dead animals be consistent with the Minnesota Board of Animal Health regulations.
- **8.** If and when rendering is used as a mortality disposal the applicant shall provide an enclosed location for the pick up.
- **9.** That adequate measures be taken to minimize or control offensive odor, fumes, dust, noise, or vibrations so that none of these will constitute a nuisance.
- 10. That the applicant will furnish a final construction report to Environmental Services verifying that the concrete manure storage structure was constructed per approved engineered design plan as required in Minnesota State Feedlot Regulations 7020.2100 Subpart 5, item D.
- 11. That the applicant maintain a manure management plan according to MPCA requirements. Said plan shall also be updated from time to time as management practices change or crop nutrient needs change and shall be available upon request of the County Feedlot Officer or MPCA.
- 12. That if a shower, restroom or laundry facility is included with the facility, that a waste water treatment system is reviewed and constructed according to County Environmental Health Department standards.

This resolution shall become effective immediately upon its passage and without publication.
