**CSAH 10 Bridge Replacement
Right of Way Acquisition**

Whereas, the CSAH 10 bridge over an unnamed stream about one mile east of Vernon Center is a deteriorated timber structure in need of replacement; and

Whereas, State Bridge Bond replacement funds have been programmed for 2006 and additional right of way is needed, including one parcel with uncertain ownership;

Therefore, be it resolved, the County Engineer and County Attorney are authorized to require the right of way for this project including the use of eminent domain if needed.
