COMMITTEE REPORTS

PLANNING AND ZONING

Mr. Veryl Morrell, Land Use Administrator, Mr. Bill Goebel, Land Use Specialist, and Mr. George Leary, Land Use Specialist, presented the following items to the Board.

Commissioner Bruender moved and Commissioner Purvis seconded the motion to approve the following resolution:

RESOLUTION GRANTING A CONDITIONAL USE PERMIT TO CONSTRUCT A TOTAL CONFINEMENT SWINE FACILITY OF 960 ANIMAL UNITS LOCATED IN AN AGRICULTURAL DISTRICT IN THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 4, LINCOLN TOWNSHIP

WHEREAS, Ted Goettl, (owner), Lance Goettl, (business partner) and Tony Jacobs, (business partner) of the following real estate in the County of Blue Earth, Minnesota, to wit:

West ½ of the Northeast Quarter (NE 1/4) of Section 4, Township 107, Range 29.

have applied for a Conditional Use Permit to construct one total confinement swine barn creating a new feedlot in an A, Agriculture Zoning District; and

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC32-06), a copy of said report has been presented to the County Board; and

WHEREAS, the Planning Commission of the County on the 6th day of September, 2006, following proper notice, held a public hearing regarding the request and, following the hearing, adopted a recommendation that the request for a Conditional Use Permit be granted; and

WHEREAS, the Blue Earth County Board of Commissioners finds that:

1. That with proper management of the proposed barn and with proper manure application, the Conditional Use should not be injurious to the use and enjoyment of other property in the immediate vicinity designated for agricultural uses.

2. That with proper management of the proposed barn and with proper manure application, this facility should not constitute a pollution problem.
3. That the predominant use in the area is agriculture. The Conditional Use should not impede the normal and orderly development and improvement of surrounding vacant property for agricultural uses.
4. Adequate utilities, access roads, drainage and other necessary facilities have been or will be provided.
5. Adequate measures will be taken to provide sufficient off-road parking and loading space to serve the proposed use.
6. Soil conditions are adequate to accommodate the proposed request.
7. Proper facilities will be provided which will eliminate any traffic congestion or traffic hazard which may result from the proposed use.
8. The feedlot is not greater than the feedlot standards allowed in the A, Agricultural Zoning District.
9. The proposed use is consistent with the County Land Use Plan.
10. That the proposed use does not include residential development.
11. That the proposed use does not include industrial development.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the request for a Conditional Use Permit, to build one total confinement swine barn in an Agriculture Zoning District, is granted with the following conditions:

1. That the total confinement barn conform with the site plan attached to this report PC 32-06.
2. That the proposed barn be located on a single, legally described parcel consisting of a minimum of ten contiguous acres. The parcel shall be a parcel of record, properly recorded in the Blue Earth County Land Records Office.
3. That the applicant must obtain a Blue Earth County Feedlot Permit before any animals are placed in the barn.

4. That the applicant obtain a Blue Earth County Construction Permit and an MPCA Construction Short Form Permit before building begins and within one year from the date the County Board of Commissioners approves the Conditional Use Permit. The permit shall be rendered invalid if application for a Construction Permit is not made within this one year period. Time extensions for Conditional Use Permits must be obtained from the County Board of Commissioners subsequent to a public hearing conducted by the Planning Commission.
5. That a perimeter footing drain tile be located as required by the structural design engineer that designs the manure storage pit. The perimeter tile shall include at least one inspection pipe with a riser. The native materials must be excavated and walls back filled with granular material (pit run gravel or equivalent) *or as required* by the designing engineer.
6. That application of manure be on the land documented in the aerial photos included in the State of Minnesota Application for Construction and Operation of an animal feedlot. The application of manure shall comply with standards set forth by the MPCA and Blue Earth County.
7. That the disposal of dead animals be consistent with the Minnesota Board of Animal Health regulations.
8. If and when rendering is used as a mortality disposal the applicant shall provide an enclosed location for the pick up.
9. That adequate measures be taken to minimize or control offensive odor, fumes, dust, noise, or vibrations so that none of these will constitute a nuisance.
10. That all manure storage structures must be designed by a registered engineer. A copy of the designed plans and soil investigation report must be submitted to Blue Earth County Environmental Services prior to the issuance of a construction permit.
11. That the applicant will furnish a final construction report to Environmental Services verifying that the concrete manure storage structure was constructed per approved engineered design plan. Said construction report shall be signed by a professional engineer registered in the State of Minnesota and will include the following: photographic documentation of reinforcing steel placement, collection of three sample concrete cylinders to be retained by the engineer / landowner for concrete compressive strength testing, and three batch tickets documenting the concrete design.

12. That the applicant maintain a manure management plan according to MPCA requirements. Said plan shall be updated if needed prior to September 1, 2006 for the Fall of 2006 application season. Said plan shall also be updated from time to time as management practices change or crop nutrient needs change and shall be available upon request of the County Feedlot Officer or MPCA.
13. That the barn is designed for and constructed with a power ventilation system.

This resolution shall become effective immediately upon its passage and without publication.

**RESOLUTION GRANTING A CONDITIONAL USE PERMIT TO TRANSFER
DEVELOPMENT RIGHTS FROM THE NE 1/4 OF THE SE 1/4 OF SECTION 08 LYRA
TOWNSHIP TO THE SE 1/4 OF THE NE 1/4 OF SECTION 08 LYRA TOWNSHIP.
THE PROPERTY IS IN AN AGRICULTURAL ZONED DISTRICT.**

WHEREAS, Charles Barnard, owner of the following real estate in the County of Blue Earth to wit:

Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 8, Township 106, Range 27 and the Southeast Quarter (SE 1/4) of the Northeast Quarter (NE 1/4) of Section 8, Township 106, Range 27.

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 34-06), a copy of said report has been presented to the County Board; and,

WHEREAS; the request to transfer development rights does not conflict with the Land Use Plan, up to four homes are permitted in any individual 1/4-1/4 section in the Agricultural Zoned District through approval of a Conditional Use Permit authorizing transfer of developments by the Blue Earth County board of Commissioners; and,

WHEREAS; the Planning Commission of the County on the 6th Day of September, 2006, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter to the County Board with a recommendation for approval subject to conditions contained in staff report No. PC 34-06, and,

WHEREAS; the County Board on the 19th Day of September, 2006, held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to approve the request subject to conditions included in staff report No. PC 34-06, and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

1. That the Transfer of Development Rights conforms with the County Land Use Plan.
2. That the Transfer of Development Rights will not degrade the water quality of the County.
3. That the Transfer of Development Rights will not adversely increase the quantity of water runoff.
4. That soil conditions are adequate to accommodate the Transfer of Development Rights.
5. That the Transfer of Development Rights does not create a potential pollution hazard.
6. That adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.
7. That the Transfer of Development Rights will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted.
8. That the establishment of the Transfer of Development Rights will not impede the normal and orderly development and improvement of surrounding vacant property for predominant uses in the area.
9. That site specific conditions and such other conditions are established as required for the protection of the public's health, safety, morals, and general welfare.
10. That the intensity of the proposed residential development is not greater than the intensity allowed in the Agricultural Zoning District.
11. Sec. 24-111 of the Agricultural District States : "Owners of property, residents, other users of property in the agricultural zone, and neighboring properties adjacent to the agricultural zone may be subjected to inconvenience or discomfort

arising from normal and accepted agricultural practices and operations including, but not limited to; noise, odors, dust, operation of aircraft and late night operation of farm machinery, the storage and application of manure, fertilizers, soil amendments, herbicides, and pesticides associated with normal agricultural operations.

Owners of Property, residents, other users of property in the agricultural zone, and neighboring properties to the agricultural zone, should be prepared to accept such inconveniences or discomfort from normal operations, and are hereby put on official notice, pursuant to MN Statutes, Chapter 561.19, that this declaration may prevent them from obtaining a legal judgment against such normal operations.”

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the Conditional Use Permit is hereby **granted** contingent upon the following:

1. The applicant divide the property in accordance with the provisions of the County Code.
2. The applicant shall present the request to the Lyra Township Board for review prior to the September 19th County Board meeting.

This Conditional Use Permit shall become effective immediately upon its passage and without publication.

FEEDLOT OF 995 A.U.S. LOCATED IN THE SOUTH HALF OF THE NORTHWEST
QUARTER OF SECTION 17, BUTTERNUT VALLEY TOWNSHIP**

WHEREAS, J. Lonny Hughes, owner of the following real estate in the County of Blue Earth, Minnesota, to wit:

The South Half of the Northwest Quarter of Section 17, Butternut Valley T. 108 N. - R. 29 W.

has applied for a Conditional Use Permit to construct one total confinement swine barn creating a new feedlot in an A, Agriculture Zoning District; and

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC-35-06), a copy of said report has been presented to the County Board; and

WHEREAS, the Planning Commission of the County on the 6th day of September, 2006, following proper notice, held a public hearing regarding the request and, following the hearing, adopted a recommendation that the request for a Conditional Use Permit be granted; and

WHEREAS, the Blue Earth County Board of Commissioners finds that:

1. That with proper management of the proposed barn and with proper manure application, the Conditional Use should not be injurious to the use and enjoyment of other property in the immediate vicinity designated for agricultural uses.
2. That with proper management of the proposed barn and with proper manure application, this facility should not constitute a pollution problem.
3. That the predominant use in the area is agriculture. The Conditional Use should not impede the normal and orderly development and improvement of surrounding vacant property for agricultural uses.
4. Adequate utilities, access roads, drainage and other necessary facilities have been or will be provided.
5. Adequate measures will be taken to provide sufficient off-road parking and loading space to serve the proposed use.

2. That the feedlot, including all buildings and the proposed barn, be located on a single, legally described parcel consisting of a minimum of ten contiguous acres. The parcel shall be a parcel of record, properly recorded in the Blue Earth County Land Records Office.
3. That the applicant must obtain an updated Blue Earth County Feedlot Permit before any animals are placed in the barn.
4. That the applicant obtain a Blue Earth County Construction Permit before building begins and within one year from the date the County Board of Commissioners approves the Conditional Use Permit. The permit shall be rendered invalid if application for a Construction Permit is not made within this one year period. Time extensions for Conditional Use Permits must be obtained from the County Board of Commissioners subsequent to a public hearing conducted by the Planning Commission.
5. If required by the Minnesota Department of Natural Resources, that the applicant obtain a Department of the Natural Resources, "Water Appropriations Permit" before any animals are placed in the proposed barn.
6. That a perimeter footing drain tile be located at or below the bottom of the pit footings. The footing tile shall include one inspection pipe for each concrete pit. The native materials must be excavated and walls back filled with granular material (pit run gravel or equivalent). *Exceptions to this may only include specific design standards submitted by the design engineer of the manure storage structure.*
7. That application of the manure be on land documented in the aerial photos included in the State of Minnesota Application for Construction and Operation of an animal feedlot. The application of manure shall comply with standards set forth by the MPCA. A manure management plan meeting MPCA requirements must be submitted for review prior to stocking the new barns. This plan must be reviewed by the operator each year and adjusted for any changes in the amount of manure production, manure nutrient test results, fields available for receiving manure, crop rotations, or other practices which affect the available nutrients amounts or crop nutrient needs on fields receiving manure as required by the MPCA. Manure application setback standards for the fields on which the manure is applied shall be followed as provided in attachment A-4.

8. That the disposal of dead animals be consistent with the Minnesota Board of Animal Health regulations.
9. If rendering is the method of choice for mortality disposal, the applicant shall provide an enclosed location for the pick up of dead animals before any animals are placed in the proposed barn.
10. That adequate measures be taken to minimize or control offensive odor, fumes, dust, noise, or vibrations so that none of these will constitute a nuisance.
11. That all manure storage structures must be designed by a registered engineer. A copy of the designed plans must be submitted to Blue Earth County Environmental Services prior to the issuance of a construction permit.
12. That the applicant will furnish a final construction report to Environmental Services verifying that the concrete manure storage structure was constructed per approved engineered design plan. Said construction report shall be signed by a professional engineer registered in the State of Minnesota and will include the following:
photographic documentation of reinforcing steel placement, collection of three sample concrete cylinders to be retained by the engineer / landowner for concrete compressive strength testing, and three batch tickets documenting the concrete design.
13. That the applicant comply with the storm-water control requirements established by the MPCA.
14. That if a shower, restrooms or laundry facility is included with the proposed addition or any other livestock barns on the site, that a waste water treatment system is reviewed and constructed according to County Environmental Health Department standards.
15. That the earthen basin located at the home site be properly abandon according to state rules and regulations by December 31st 2007.

This resolution shall become effective immediately upon its passage and without publication.

WHEREAS, Mark Morris, owner of the following real estate in the County of Blue Earth to wit:

As identified on the final plat of Morris Woods Subdivision,

is requesting that the residential development right be transferred from the NE 1/4 of the NW 1/4 to the SE 1/4 of the NE 1/4 to the NE 1/4 of the SW 1/4 of Section 3, Beauford Township to add additional land and roadway frontage onto an existing landlocked lot of record. If this TDR is approved a one lot residential subdivision (to be known and recorded as the Morris Woods Subdivision) will be submitted for approval; and,

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 36-05), a copy of said report has been presented to the County Board; and,

WHEREAS; The proposal does not conflict with the land use plan. Single-family dwellings are a permitted use in the Agricultural District. The County Land Use Ordinance allows transfer of development rights from one adjacent quarter-quarter to another with no more than four dwellings allowed in any one quarter-quarter in this zoning district; and,

WHEREAS; the Planning Commission of the County on the 6th Day of September 2006, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter to the County Board with a recommendation for approval subject to conditions contained in staff report No. PC 36-05, and,

WHEREAS; the County Board on the 19th Day of September, 2006, held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to approve the request subject to conditions included in staff report No. PC 36-05, and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

1. That the proposed use conforms with the County Land Use Plan.
2. That the proposed use will not degrade the water quality of the County.
3. That the proposed use will not adversely increase the quantity of water runoff.
4. That soil conditions are adequate to accommodate the proposed use.
5. That the proposed use does not create a potential pollution hazard.
6. That adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.
7. That the Conditional Use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted.
8. That the establishment of the Conditional Use will not impede the normal and orderly development and improvement of surrounding vacant property for predominant uses in the area.
9. That the density of proposed residential development is not greater than the density of the surrounding neighborhood or the density indicated by the applicable Zoning District.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the Conditional Use Permit to transfer the development right is hereby **granted** contingent upon the following:

1. The property will be subdivided pursuant to the Blue Earth County Code of Ordinances.
2. The identified wetland easement needs to be pinned to accommodate future reference.
3. Construction and septic permits will be obtained prior to commencement of construction activities.

This Conditional Use Permit shall become effective immediately upon its passage and without publication.

is requesting preliminary and final plat approval for the Morris Woods Subdivision; and,

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 37-05), a copy of said report has been presented to the County Board; and,

WHEREAS; The proposal does not conflict with the land use plan. Single-family dwellings are a permitted use in the Agricultural District; and,

WHEREAS; the Planning Commission of the County on the 6th Day of September 2006, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter to the County Board with a recommendation for approval subject to conditions contained in staff report No. PC 37-05, and,

WHEREAS; the County Board on the 19th Day of September, 2006, held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to approve the request subject to conditions included in staff report No. PC 37-05, and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

1. The proposed subdivision conforms with the Land Use Plan.
2. The soil conditions are adequate to support the proposed use.
3. Adequate utilities, access roads, parking, drainage, and other necessary facilities have been or are being provided.
4. The proposed subdivision will not degrade the water quality of the County.

5. The proposed subdivision will not be injurious to the use and enjoyment of other property in the immediate vicinity for purposes already permitted.
6. The proposed subdivision will not impede the normal and orderly development and improvement of surrounding vacant property for the predominant uses in the area. That the proposed use conforms with the County Land Use Plan.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the preliminary and final plat of Morris Woods Subdivision are hereby **granted** contingent upon the following:

1. The developer of the subdivision acknowledges and understands the following cautionary disclosure from the Blue Earth County Code of Ordinances, Division 2. Agricultural District, Section 24-111 Purpose, Subpart (b) Agricultural operations. Said disclosure states:

Through the adoption of this subsection, the board of commissioners is expressing its intent to enhance and encourage agricultural operations within the boundaries of the county. The county will view the agriculture district as a zone in which land is used for commercial agricultural production. Owners of property, residents, other users of property in the agriculture zone, and neighboring properties adjacent to the agriculture zone may be subjected to inconvenience or discomfort arising from normal and accepted agricultural practices and operations including, but not limited to; noise, odors, dust, operation of aircraft and late night operation of farm machinery, the storage and application of manure, fertilizers, soil amendments, herbicides and pesticides associated with normal agricultural operations. Owners of property, residents, other users of property in the agriculture zone, and neighboring properties adjacent to the agriculture zone, should be prepared to accept such inconveniences or discomfort from normal operations, and are hereby put on official notice, pursuant to Minn. Stats. ch. 561.19, that this declaration may prevent them from obtaining a legal judgment against such normal operations.

2. All required infrastructure (monumentation) must be installed and accepted prior to recordation of the final plat
3. The final plat must be recorded within one year of approval by the Blue Earth County Board of Commissioners.
4. Construction and septic permits will be obtained prior to commencement of construction activities.

This preliminary and final plat approval shall become effective immediately upon its passage and without publication.

RESOLUTION GRANTING A CONDITIONAL USE PERMIT AUTHORIZING THE ESTABLISHMENT AND OPERATION OF AN OIL FILTER RECYCLING FACILITY AS A LEVEL II HOME OCCUPATION IN AN EXISTING BUILDING ON AN ESTABLISHED BUILDING SITE IN THE AGRICULTURE ZONED DISTRICT IN THE NW 1/4 OF THE SW 1/4 OF THE SE 1/4, SECTION 17, MEDO TOWNSHIP.

WHEREAS, Brian Nelson lessee, and Merlin Schoenrock, owner of the following real estate in the County of Blue Earth to wit:

NW corner of the NW 1/4 of the SW 1/4 of the SE 1/4, Section 17, Medo Township, Blue Earth County, Minnesota,

are requesting that they be permitted to install an oil filter recycling machine in an existing 40 foot by 48 foot building on the Merlin Schoenrock building site in the NW corner of the NW 1/4 of the SW 1/4 of the SE 1/4, Section 17, Medo Township; and,

WHEREAS, the Planning Agency of the County has completed a review of the application and made a report pertaining to said request (PC 38-06), a copy of said report has been presented to the County Board; and,

WHEREAS; the request to establish and operate an oil filter recycling business as a Level II Home Occupation does not conflict with the Land Use Plan. It is a conditional use in the Agriculture Zoned District; and,

WHEREAS; the Planning Commission of the County on the 6th Day of September 2006, following proper notice held a public hearing regarding the request, and following due consideration of presented testimony and information, voted unanimously to forward the matter to the County Board with a recommendation for approval subject to conditions contained in staff report No. PC 38-06; and,

WHEREAS, the Blue Earth County Board of Commissioners finds:

1. The proposed use does not conflict with the County Land Use Plan.

2. The applicant has demonstrated a need for the proposed use.
3. If properly done the proposed use will not degrade the water quality of the County.
4. The proposed use will not adversely increase the quantity of water runoff.
5. The soils are adequate to accommodate the proposed use.
6. If properly done the proposed use should not create a potential pollution hazard.
7. Adequate utilities, access roads, drainage and other necessary facilities have been or are being provided.
8. Adequate measures have been or will be taken to provide sufficient off-road parking space to serve the proposed use.
9. If properly done the Conditional Use should not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted.
10. Establishment of the Conditional Use will not impede the normal and orderly development and improvement of surrounding vacant property for the predominate uses in the area.
11. That site specific and such other conditions are established to protect the public's health, safety and general welfare.

NOW THEREFORE BE IT RESOLVED, by the Blue Earth County Board of Commissioners, that the request to approve an oil filter recycling facility as a Level II Home Occupation is hereby **granted** contingent upon the following:

1. Secondary containment shall be designed into the facility as required by the Blue earth County Hazardous Waste/Solid Waste Section of Environmental Services.
2. All recycling activities shall be performed in accordance with pertinent State and/or Federal rules. All pertinent State and/or Federal permits must be obtained prior to commencement of recycling activities. Said permits shall be maintained.
3. Construction permits need to be obtained prior to commencement of construction.

4. The building remodeling (floor/secondary containment) shall comply with the approved plans made part of this report.
5. Any unused wells on the building site shall be properly sealed.

This Conditional Use Permit shall become effective immediately upon its passage and without publication.
