Note: The permit application fee must be paid to Blue Earth County when submitting an application. The application fees for the Land Disturbance Permit are:

- Land Disturbances under one acre: \$200
- Land Disturbances of one acre or more: \$450

Note: A County Land Disturbance Permit is required when any project disturbs:

- 5,000 Square Feet or more in Rural Townsite, Rural Residence, Heavy Industrial, Light Industrial, Highway Business or General Business Zoning Districts in South Bend Township.
- 1-Acre or more in the Agricultural or Conservation Zoning Districts in South Bend Township.
